Minimum numbers in the Trinity Suite is 60 people.

Maximum numbers dining in the Trinity Suite is 100 people including the Tofi Table.

Maximum of an additional 60 people at the after's.

Trinity Suite Bar will close at 11:30pm Sunday-Thursday and 12:30am on Friday and Saturday nights. A bar extension can be applied for in which case the bar will close at 1:30am and guests must vacate the Suite by 2:00am. The bar extension must be applied for through the courts and is subject to their approval. For us to apply for this extension, we require a minimum of 3 months' notice. Once granted, this cannot be cancelled and the cost will be incurred by the booker.

Music must finish by 12:00am except where a Bar Extension has been acquired in which the music may continue until 12:30am. In the interest of other residents, the music must be kept to a reasonable level.

TERMS AND CONDITIONS

- ♦ The Granville Hotel, hereafter referred to as 'the hotel', hosts only one wedding per day. However, the hotel reserves the right to host more than one events, other than a wedding, on any day. As such, exclusive use of the entire function and banqueting areas that are not included as part of the wedding package is never guaranteed. The Granville Hotel will endeavor to ensure your special day is a great success.
- ♦ All references to 'the package' refer to the wedding package provided by the hotel and include all civil ceremony packages where applicable.
- ♦ A provisional booking, with no obligation to confirm your preferred date, will be held for 14 days, subject to availability.
- ♦ All weddings must be booked a minimum of 8 months in advance.
- ♦ A non-refundable deposit of €1,500 is required to secure and confirm the booking date. The deposit is transferrable for a period of 12 months.
- ♦ To avail of our wedding package on a Friday or Saturday, a minimum of 80 adults is required.
- ♦ Please note that an extra charge may be incurred should the wedding meal sit later than the time agreed prior to the wedding date.
- ♦ The final number of attending guests charged if required 48-hours prior to the wedding date. This will be deemed as minimum numbers charged for the day. Any increase in numbers will be charged accordingly.

- Prices quoted are fixed for 2025 and include VAT, however, prices are subject to annual increase or changes in VAT.
- Menu choice is to be made one month prior to the function. The chosen menu must consist of five courses.
- The hotel will not be liable for any failure or delay in providing facilities, services, food or beverages as a result of force majeure events and/or matters outside of its control.
- The hotel does not accept responsibility for any item(s) including, but not limited to; wedding gifts, cards, cash and/or any item which may be handed to any staff member. We strongly advise that an appointed member of your wedding party look after this and the person's name be made known to the Wedding Team prior to the wedding date. Safes are provided in the Bridal Suite and all other guest bedrooms. Items are deposited at the owner's risk.
- No food or beverage items may be brought into the hotel or consumed on site (apart from a wedding cake) and all HACCP regulations apply to external suppliers.
- Full payment of the pro forma invoice for wedding is required 12 working days prior to the wedding date by bank draft or cash. Failure to do so may result in cancellation of the event.
- The hotel reserves the right to cancel the event and refund the deposit in the circumstances where the booking is made through a third party and/or under fraudulent pretenses. Wedding bookings must be made in the presence of both parties of the wedding couple.

We may offer your wedding guests a special overnight accommodation rate based on availability. All individual bookings are to be guaranteed by a credit card at the time of booking. The hotel cannot guarantee that a certain grade of room will be available at the time of booking.

- ♦ The hotel reserves the right to bill any charges at a later date that are outstanding at the time of final payment.
- ♦ On confirmation of your wedding party, the bridal suite is complimentary for the night of the wedding based on wedding number over 60 guests. For weddings over 80 guests, 10 rooms can be reserved at a reduced rate, however, the hotel reserves the right to cancel any bookings not guaranteed by credit card 4 weeks prior to the wedding date.
- ♦ It is the hotel's policy to close our bars punctually in accordance with current licensing laws, including any extension to serving hours provided. The hotel reserves the right to close any/all bars and eject any guest(s) from the premises that they deem to be displaying behavior that is inappropriate, aggressive, and/or a danger to health, safety or welfare of any other person(s) on the premises including staff and/or any other guest of the hotel in accordance with the Intoxicating Liquor Acts X
- ♦ Amplified music must stop by 12:30am.
- ♦ The hotel may cancel an event if it might prejudice the reputation of the hotel, and in such event, the hotel will refund all advance payments made but will have no further liability.
- ♦ The Resident's Bar is strictly only available to resident guests of the hotel and remains open at the discretion of management, who reserve the right to close the bar at any time should they deem it appropriate in the circumstances.
- ♦ Payment of the deposit indicates an acceptance and understanding of these Terms & Conditions.

- A copy of these Terms & Conditions must be returned, signed, along with the deposit to secure your wedding date.

Payment Schedule

- €1,500 - Initial deposit to secure wedding dates
- 80% of expected balance to be paid 30 days before the wedding date.
- Full and final payment to be made the day of or the morning after the wedding.
